Sub: AICTE approval to the Manohara Education Society, Warangal, Andhra Pradesh for establishment of a Polytechnic at Anantsagar Village, Warangal, Andhra Pradesh

Sir,

I am directed to state that on the basis of the recommendations of the Expert Committee of the Southern Regional Committee (SRC) of the All India Council for Technical Education (AICTE) which visited the Polytechnic on 19-6-1992 and the recommendations of the SRC made on 30-10-1992 and the subsequent compliances made by the Society, the AICTE has accorded approval to the Manohara Education Society, Warangal, Andhra Pradesh for establishment of a Polytechnic at Anantsagar Village, Warangal for conduct of the following three 3-year Diploma courses with the annual intake indicated against each from the current academic session which started in January 1993 or from the subsequent academic session subject to grant of permission by the Government of Andhra Pradesh:-

Electronics & Communication Engineering	60 (Sixty)
Mechanical Engineering	60 (Sixty)
Computer Science & Engineering	40 (Forty)

This approval is subject to fulfilment of the following conditions:-

- 1) The Director of Technical Education, Government of Andhra Pradesh should ensure that all the necessary infrastructural facilities and faculty in adequate strength are in position at the temporary location before making the admissions to the Polytechnic.
- 2) The new building should be constructed and provided with all infrastructural and other facilities for the I & II year classes by July 1994.
- 3) AICTE pay scales should be paid to all the teaching faculty with immediate effect.
- 4) The Management of the Polytechnic including the Governing Council should be constituted as per the guidelines of the AICTE.

- 5) All admissions should be made as per the norms and guidelines of the AICTE as adopted by the State of Andhra Pradesh.
- 6) The tuition and other fees should be charged as prescribed by the State Government within the overall criteria prescribed by the AICTE from time to time. No capitation fees should be charged from the students/ guardians of the students in any form.
- 7) The accounts of the Polytechnic should be audited by a Chartered Accountant and should be open for inspection by the AICTE or anybody authorised by it.
- 8) The teaching and other staff should be recruited according to the procedure, guidelines and experience prescribed by the AICTE.
- 9) No new course should be started without the prior approval of the AICTE.
- 10) The intake in any of the approved courses should not be altered under any circumstances without the prior concurrence of the AICTE.
- 11) The permission of the affiliating body should be obtained before making admissions to the proposed courses.

This approval is subject to full compliance with the SCHEME as prescribed by the Supreme Court of India in its Judgment dated 4-2-1993 on Writ Petition (C) No. 607 of 1992 with other WPs in the case of Unnikrishnan, J P. and others etc. etc. vs State of Andhra Pradesh and others etc. etc. and the related guidelines and criteria as may be issued by the AICTE or the Central Government from time to time".

The Management should strictly follow any further conditions as may be laid down by the AICTE from time to time.

In the event of non-compliance by the Trust or the Institute with the above conditions of the AICTE, the AICTE will be free to take measures for withdrawal of its approval without consideration of any related issues and that all the consequent liabilities would be that of the Trust and/or the Institute.

An Expert Committee of the AICTE will visit the College by the end of the academic year 1993-94 to review the progress made in fulfilling the conditions laid down by the AICTE and recommend continuation of the AICTE approval or otherwise.
